 College.
- Students should display their Identity Card prominently, while they are within the campus and while travelling in the College bus.
- All Students should dress in a presentable manner with college uniform.
- The management reserves the right to modify the class timings and schedule.
- Students should not hold any meetings or collect any money from other students without proper permission from the HOD.
- Students should not involve themselves in any political or religious activity inside the Campus.
- Ragging in any form is totally banned and is punishable as per the Government Order. If
 any student is found to be indulging in any sort of ragging or harassment to juniors or
 other fellow students, inside or outside the campus, bus, hostel, he/she will be dismissed
